In order to conduct/ defend Himachal Pradesh Power Corporation Ltd. in the Hon'ble Himachal Pradesh High Court and District Courts, following terms and conditions of payment of fee etc. to the Standing Counsels cum Legal Advisors / empanelled Lawyers are hereby approved:-

Sr. No	Description of Job	Fee Schedule
1	Retainership Fee (Payable to Retainer Counsel only)	Rs.2500/- PM
2	Fee for CWP	Rs.4000/- per case
3	Civil Suit	Rs 6000/- per case plus Actual expenses on account of court fee, process fee, diet money, inspection of court files etc
4	Fee for Senior Counsel /Counsels with long experience	Rs.10000/- per case
5	Clerkage for item no. 2 to 4 above.	@ 10% of the fee payable.
District Court at Shimla/ Courts at Jubbal/Rohru		
6	Retainership Fee (Payable to Retainer Counsel at Shimla Courts only)	Rs.2000/- PM
7	Cases before District Courts/ Consumer Redressal Forum/ State Consumer Commission, Commissioner WC/ Labour Court	Rs. 3500/- consolidated per case + reimbursement of actual expenses on account of court fee, process fee, diet money, inspection of court files etc

The fee shall be regulated as under:-

- 50% amount of fee shall be paid as soon as the case is taken up by the counsel.
- Balance 50% amount shall be paid on culmination / conclusion of the case.
- For tendering legal opinion no fee will be admissible to retainer counsel.
- In case there is a change of the counsel in an ongoing case, only remaining 50% fee will be admissible in respect thereof to the new counsel.
