"Examined. Terms and conditions of fee alongwith engagement in respect of the concerned advocates as detailed below are approved by the Law Deptt. subject to the condition that the expenditure will be borne by the HP Power Corporation Ltd. itself after completing all the codal formalities:-

1. The terms and conditions for filling the appeal in the Hon'ble High Court of HP against the order passed by Hon'ble ITAT Chandigarh in respect of Sh. Ajay Vaidya, Advocate in each appeal shall be as under:-

- i. Professional fee : 11,000/- (Rs. Eleven Thousand) only.
- ii. Misc. Expenses for filling appeal shall be payable as per actual.

2. The terms and conditions for filling the appeal in the Hon'ble ITAT Chandigarh in Income Tax case in respect of Sh. Vishal Mohan, Advocate in each appeal shall be as under:-

- i. Professional fee: Rs. 30,000/- (Rs. Thirty Thousand) only.
- ii. TA/DA, as admissible for Grade-I Officers of the Corporation.
