All the aforesaid posts are initially for duration of six months or till the filling up of these posts by other mode of recruitment by HPPCL, whichever is earlier. The applicant must be a retired employee from Government Department/ Undertaking/ Autonomous bodies etc., and should not be more than 65 years of age as on 31.03.2016 and should be willing to work in projects sites under HPPCL. An applicant may apply for one post only.

B. Other Terms & Conditions of Engagement:

- **Fixation of remuneration:** For pensioners, the monthly remuneration of re-employed personnel will be on the basis of last pay drawn at the time of retirement minus pension and for non-pensioners monthly remuneration will be based on pay in pay band plus grade pay being drawn at the time of retirement from the respective post.

In addition to this, re-employed personnel posted in Kashang HEP shall also be allowed special project site allowance (SPSA) at par to regular personnel appointed in Kashang HEP on monthly pay as per entitlement and applicability for the respective posts in HPPCL.

- **Tenure:** The tenure of engagement against the respective post for which incumbents are to be engaged shall be initially for a period of six months and can be further extended.

Provided further that HPPCL can terminate this engagement even before the expiry of the above period by giving notice of one month in advance or paying one month's salary in lieu of notice of one month in case the conduct and performance of the Re-employed Personnel is not found satisfactory or the service are not required anymore.

- **TA/DA:** Re-employed personnel shall be entitled to TA/DA as admissible/ entitled to equivalent categories in the Corporation under its rules/ instructions against the respective post for which engaged.
- **Leave:** CCS (Leave) Rules, 1972 shall not be applicable and will also not be entitled to LTC facility. Re-employed personnel will however be entitled to one casual leave for each completed month.
- **Medical Facilities:** Re-employed personnel shall be entitled to avail medical facilities and grant of re-imbursment of Medical Expenses as admissible under the rules/ instructions.
- **Residential Accommodation:** Re-employed personnel will be entitled to the allotment of bachelor accommodation, if available or otherwise re-employed personnel will be entitled to receive House rent Allowance as per State Government Rules and instructions.

- **Other Facilitates:** Re-employed personnel shall be entitled to all perks and facilitates at par with the respective post in HPPCL against which engaged.
 - Re-employed personnel will perform routine works at work places and will reside at a place where he is posted from time to time.
