

Shimla (H.P) and should be placed in a separate envelope along with the tender.
2. Tender without Security deposit /earnest money or less than that prescribed shall not be entertained and are liable to be rejected.
3. Telephonic/ conditional tenders shall not be entertained.

- If the date of opening of above tender happens to be a holiday, the tenders shall be received/ opened on the next working day at the same time.
5. The undersigned reserve the right to reject any or all the tenders without assigning any reasons thereto.
 6. First preference will be given to contractor/ firms of MPAF/PAF/ PAP/PAA/PAZ.

 8. **The application for tender form must be accompanied PAN number.**
 9. The tenderers who have not got the vehicle as on date of submission of bid will be given one month time for procurement of vehicle after finalization of rates and issue of Letter of Intent. If they fail to deploy the vehicle by the stipulated time period the Letter of Intent shall stand withdrawn & security deposit forfeited.
 10. Vehicle should come with taxi permit & driver having valid transport license
 11. The bids shall be in three envelops. One envelop shall contain the Demand draft towards Security deposit /earnest money, second envelop shall contain the price bid and shall be superscribed as such. Both these envelops shall be filled and submitted in the third envelop with full postal/ email address written over it. First envelope containing demand draft shall be opened first. Price bids of only those bidders shall be opened whose demand draft enclosed as Security deposit /earnest money is found in order.
 12. The bidder(s) shall have no right to withdraw the bids; otherwise Security deposit /earnest money deposited shall be forfeited.
 13. The rates shall be valid for 120 days from the date of opening of the tenders.
