DETAILED TERMS & CONDITIONS

1. **Age Limit:** The minimum age limit is 18 years and the maximum will be 30 years as on 01.01.2026. (Relaxable by 05 years for SC/ST/OBC (Non-Creamy Layer)/PWDs/ PAFs of HPPCL)
2. **Stipend: Rs. 12,300/- Per Month.** Apart from monthly stipend; no other monetary or non-monetary benefits such as HRA, Conveyance, Medical facility etc. shall be admissible to apprentices.
3. **Bachelor accommodation** will be provided in projects, **subject to availability only.**
4. **Training duration:** One Year (without any extension whatsoever).
5. **Female candidates will be preferred over male candidates.** Result awaited candidates need not to apply.
6. Candidates with qualification acquired through Distance Learning Mode or Part Time Mode or correspondence mode shall not be considered.
7. Wherever CGPA/OGPA or Letter Grade is awarded in the Diploma /Degree examination, its equivalent aggregate percentage of marks must be indicated in the Application Form as per the norms adopted by University / Institute.
8. Candidates have to apply for **ANY ONE TRADE / DISCIPLINE ONLY.** Candidates applying for more than One Trade/ discipline will not be considered and their applications will be summarily rejected.
9. No extension of apprenticeship will be given after the completion of one year apprenticeship training by HPPCL.
10. HPPCL shall have no obligation to offer regular employment to apprentices during and/or after the completion of the apprenticeship period.
11. The candidates who have already undergone training or job experience of one year or more after completion of their educational qualification shall be ineligible.
12. **Selection Criteria: There will be no interviews.** The candidates have to attend the document verification in person on the prescribed dates. Subsequently, the eligible candidates will be shortlisted and selected on the basis of merit list formed on the basis of marks secured in Matriculation examination (10th), 12th or ITI Course/ Diploma and essential qualification of the trade, as per following details:
The candidates will be shortlisted on the following criteria:-
 - Weightage of Marks obtained in Matriculation: 20%
 - Weightage of Marks obtained in 10+2 or Diploma (In case of both, whichever is higher): 20%
 - Weightage of Marks obtained in essential qualification: 60%**Total Marks: 100**
13. **Order of preference for selection:**
 - i) Candidates belonging to Project Affected Family (PAF) of HPPCL.
 - ii) Candidates belonging to Project Affected Areas (PAA) of HPPCL.
 - iii) Candidates in order of merit.Candidates belonging to Project affected Family/ Areas have to attach documentary proof for the same, duly signed by the Concerned Deputy Commissioner or Head of Project, HPPCL strictly as per the R&R Plan of HPPCL.
14. The list of shortlisted candidates will be displayed in the official website of HPPCL. No separate intimation shall be made in this regard.
15. The candidates on the basis of information provided in the Application Form shall have to produce all original testimonials/certificates at the time of verification/ documentation along-with one set of self attested copies of the same. In case any information/claim made by the applicant in her/ his application is found to be false, the candidature of such applicant shall be cancelled and she shall be liable for prosecution.

16. The candidate must ascertain the correctness of all information before filling the Application Form and its final submission.
17. The decision of Management will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full etc. No correspondence will be entertained in this regard. Filling up of the seats is solely at the discretion of the management based on suitability of candidates and no claim will arise for engagement, if some of these seats are not filled due to unsuitability / insufficient number of candidates.
