Sealed quotations (NIQ) are hereby invited by the undersigned on behalf of Himachal Pradesh Power Corporation Limited (HPPCL) for the job work "Safety testing of lifting machines, hoist & lift and pressure plant in respect of Intgrated Kashang Hydro-Electric Project Stage-1, HPPCL, Reckong Peo, Distt.-Kinnaur, (HP)" from the reputed/experienced authorized Person/ Firm/ Agency/ Chartered Engineers registered with Chief Inspector of Factories, Govt. of Himachal Pradesh or Central/ any other State Govt. Organization subject to below mentioned terms & conditions. The quotations should reach in the office of undersigned on or before 25.11.2025 at 11:00 AM and the same shall be opened on the same day at 11:30 AM by the tender committee constituted for the purpose in the presence of bidders or their authorized representatives who may wish to be present at that time. The Price Schedule is attached as Annexure-A.

Terms and Conditions:-

- 1. Rates of inspection, testing at site & issuing of verified test report certificate to be submitted shall be F.O.R. at Integrated Kashang Hydro-Electric Project, Stage-I, HPPCL, Reckong Peo, Distt-Kullu, (HP)-172107 inclusive of to & fro charges, accommodation charges etc., forwarding charges of verified test report & all other charges whatsoever and shall be FIRM.
- 2. The evaluation of quotations shall be done without considering GST. The GST shall be paid extra as per actual applicability at the time of invoicing.
- 3. The quotations should be strictly as per the above specified price schedule / bill of quantity and terms & conditions of HPPCL duly signed / stamped and quotations with any deviation in the same shall be rejected.
- 4. The prospective bidders are requested to submit the bid/offer in a sealed cover along with all relevant documents superscribed with short term notice inviting quotation (NIQ) Ref. No.and quotation opening date along with the name and address of the bidder clearly mentioned on the envelope. The sealed envelope should be sent at the address of undersigned.
- 5. The quotations received through e-mail or fax shall not be considered.
- 6. The copy of GST certificate, PAN card, certificate of authorization issued by Chief Inspector of Factories, Govt. of Himachal Pradesh or State/Central Govt. Organization, MSME certificate (if applicable) should be submitted with the offer/bid/quotation.
- 7. The rates quoted by the bidders shall be valid for **120 days** from the date of opening of quotations.
- 8. HPPCL shall not be responsible for delay / failure in submission of the quotations.
- 9. The quotations received after due date & time shall not be accepted under any circumstances.
- 10. In case the scheduled date of opening of quotations happens to be a holiday, the quotations shall be opened on next working day.
- 11. HPPCL reserve its right to reject any one or all the quotations without assigning any reason thereof.
- 12. The quantity can be increased or decreased at the time of issuing of job order.

- 13. The complete verified tests reports certificates of testing of lifting machines, hoist, lift & pressure plant and other equipments shall be submitted by contractor within six (06) weeks after the issue of job order which is inclusive of inspection, testing and execution of the work at site.
- 14. The job order has to be completed within the schedule period, no extension of time will be given to contractor, delay in completion of work and penalty thereof will be imposed as per the prevailing practice of HPPCL (i.e. @ 0.5% per week plus applicable GST or part thereof subject to maximum 5% of the Contract Price plus applicable GST).
- 15. If the delays shall have arisen from any causes beyond the control of the contractor. HPPCL will allow additional time as he may consider to have been required by the circumstances of the case without any extra cost.
- 16. No advance payment will be given. The 100% job order payment inclusive of GST shall be released directly to Contractor/Firm account through NEFT/Cheque after receipt of GSTN Invoice in original, verified complete test reports & other documents etc. No request for other mode of payment shall be entertained.
- 17. The contractor shall make his own arrangement for accommodation, visiting to site for execution of job work & local transportation to the different sites for testing purpose etc.
- 18. The contractor shall give proportionate progress as per time schedule fixed for completion. In case any lapse is occurred, the HPPCL shall have full right to rescind the order and get the work done through any other agency at the risk & costs of contractor.
- 19. Any variation in quantities against various items for the execution of testing shall have no effect on the contract rates.
- 20. All the T&P, material and manpower required for the work shall be arranged by the contractor at his own cost.
- 21. The work shall be carried out as per standard specifications & as per the instructions of the EIC.
- 22. In case of any dispute between the HPPCL & Contractor, the jurisdiction of court shall be at Reckong Per, Distt.-Kinnaur, (H.P.) only.
- 23. All statutory provisions of various Acts, such as Minimum Wages Acts, Workman Compensation Acts, Contract Labour Act-1970, Payment of Wages Act, EPF and miscellaneous provision Acts 1952/ESI Acts, Insurance Acts, Women Acts and any other statutory provision as applicable to Contract Labour should be duly complied with. All the requisite records & return as per Acts mentioned above are to be maintained properly. Contractor shall invariably submit EPF challan showing deposit of EPF dues along with bill. The contractor shall have to obtain Labour License/ insurance of their Labour engaged, if required. In case of any mishappening all financial liability shall be borne by the Contractor.
- 24. Every person engaged by contractor should have identity card issued by Labour officer or Contractor himself.

- 25. Proper care should be taken for health & safety of the workmen as per provisions contained in the prevailing Acts. Other related measures & compliance as issued by appropriate Govt. from time to time.
- 26. If the contractor does not complete the job order / leaves the work willfully incomplete after the job work is awarded, he shall not be allowed to participate in the tenders of HPPCL for next six months.
- 27. The conditions specified above shall be final and binding on the contractor.
- 28. The contractor shall also supply the authenticity of for providing skilled/ experienced technical manpower to HPPCL before award of job work.
- 29. All statutory deductions as may be applicable shall be deducted at source.
- 30. In case of statutory changes in taxes and duties structure or imposition of any other taxes and duties, the same shall be borne by HPPCL extra at the rates prevailing at the time of execution.
- 31. Transit insurance shall be arranged by the contractor.
- 32. The man power engaged for this job order execution shall be equipped with safety gears.
- 33. Any kind of loss / damage occurred during the execution of job order, the contractor will be fully responsible for the same, nothing will be paid by HPPCL.
- 34. The contractor will be fully responsible for any type of accident (non-fatal/ fatal) take place during execution of job order. The contractor will have to provide all the medical facilities and compensation if any on his account at his own cost and nothing extra will be paid on this account by HPPCL.
- 35. While generating the invoice for payment purposes, HPPCL GSTN No. i.e. 02AABCH8615G1ZX be mentioned appropriately.
