Bid Security / Earnest Money Deposit (EMD) <b>INR 11,000/- only.</b>	The tender must be accompanied with earnest money in the form of a Demand Draft (DD) in favour of HPPCL, Sawra Kuddu HEP payable at Sawra/Rohru (HP) amounting to Rs. 11000/- only (Rupees Eleven Thousand only).



**D. PREPARATION OF BIDS:**

- i) For preparation of the bid(s), the bidder(s) should take into account the corrigenda (if any) published on the tender document before submitting their bids.
- ii) Bidder(s) is advised to go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of bid documents to be submitted including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

**E. SUBMISSION OF BIDS:**

- i) The bidder's authorized representative has to sign the required bid/Tender documents as indicated in the bid/tender document(s).
- ii) The bidder(s), along with its bid, should submit Notarized Power of Attorney supported with necessary supporting documents in respect of its authorized representative, as written confirmation of authorization to sign on behalf of the Bidder.
- iii) Bidder should prepare/submit the Bid Security (EMD) as per the instructions specified in the bid/tender document.
- iv) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the Price Bid format is found to be modified by the bidder, the bid will be rejected.

**F. ASSISTANCE TO BIDDERS:**

- i) Any queries relating to the bid/tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.

**G. OTHER TERMS & CONDITIONS:**

- i. All amounts mentioned above, except Bid Security (EMD), are non refundable. EMD deposited against other procurement(s) shall not be transferable to this tender and vice versa.
- ii. Bids without Bid Security (EMD) will not be entertained and shall be rejected outrightly.
  - a. HPPCL will not be responsible for costs or expenses incurred by bidders in connection with the preparation or submission of bids and site visit etc. The bidder shall at his own cost visit the site where works is to be carried-out for acquainting himself regarding the site conditions.
  - b. In case the scheduled date happens to be a holiday, the tenders will be opened on next working day.
  - c. Telegraphic Tenders/ Conditional Tenders/ Tenders through other than prescribed mode will not be entertained.
  - d. HPPCL reserves the right to reject any or all tenders without assigning any reason thereof.
  - e. The bid documents are not transferable and cost of bid document is not refundable under any circumstances.



f. Bids after due date & time will not be accepted under any circumstance.


g. Detailed Terms & Conditions can be seen in the Bid/Tender Document.

- iii. Bidder should be a reputed Govt. Contractor registered with HPPCL/HPSEBL/HPPWD/CPWD/MSME or other state or Central Govt. Organization.
- iv. The work should be carried out to the entire satisfaction of the Engineer-in-Charge.
- v. No advance payment shall be released to the contractor.
- vi. 100 % payment shall be released on prorated basis/month wise as per the work done against verified RA Bills by Engineer-in-Charge.
- vii. The GST shall be paid/reimbursed extra as per actual applicability at the time of invoicing on actual values of work done.
- viii. Other applicable Taxes/Cess/Security will be deducted from the bill as per prevailing rules & regulations.
- ix. Bidder shall submit the valid registration/ renewal (registered with HPSEB, HPPWD, CPWD or other state/Central Govt. Organization/MSME), PAN Card (Income Tax) and EPFO registration certificate/ allotment code number iro Bidder along with submission of the tender.
- x. The Bidder shall submit the following forms/documents with its bid:
  - a. Bank details duly authenticated by bank/ copy of cancelled cheque,
  - b. Copy of Registration No. under GST,
  - c. Copy of valid registration/ renewal (registered with HPSEB, HPPWD, CPWD or other state/Central Govt. Organization/MSME),
  - d. Copy of PAN No.,
  - e. Demand Draft (DD) in favour of HPPCL, Sawra Kuddu HEP payable at Sawra/Rohru/Shimla (HP) against Bid Security / Earnest Money deposit (EMD) as proof of appropriate amount.

- xii. Bids without Bid Security (Earnest Money Deposit) will not be entertained and shall be rejected.
- xiii. The undersigned reserves the right to reject any or all the tenders without assigning any reason thereof.
- xiv. The Contractor / bidder must visit the site of work in their own interest. HPPCL will not be responsible for costs or expenses incurred by bidders in connection with the preparation or submission of bids and site inspection/visit etc.
- xv. Submission of tender by a bidder implies that he has read the NIT and all other tenders documents and has made himself aware of the scope and specifications of the work to be done and of conditions and other factors which may have bearing on the execution of the work.
- xvi. Quantity can be increased or decreased.



- xvii. The offer shall remain valid for a period of **120 days** from the date of submission of the tender. If any contractor withdraws his offer within this period the earnest money deposited shall stand forfeited to the HPPCL.
- xviii. Conditional Tenders/ Tenders through other than prescribed mode will not be entertained.
- xix. A bidder should quote item wise unit rates sub-totals and total prices in figures as well in words. It should not contain any interlineations or overwriting.
- xx. The bid documents are not transferable and cost of bid document is not refundable under any circumstances.
- xxi. Bids after due date & time will not be accepted under any circumstances.
- xxii. HPPCL shall not be responsible for delay/failure in submission of the bids.
- xxiii. The manpower engaged for subject cited work shall be equipped with safety gears.
- xxiv. Any kind of losses/ damages occurred during the execution of work, the contractor will be fully responsible for the same and nothing will be paid by HPPCL.
- xxv. The contractor will be fully responsible for any type of accident (non-fatal/fatal) that takes place during the execution of work.
- xxvi. The contractor is liable to pay minimum wages to skilled / semi-skilled worker/unskilled workers engaged by him for this work as per the minimum wages fixed by the Labor and Employment Department, Govt. of Himachal Pradesh under Minimum Wages ACT or any other applicable law and nothing extra on this account shall be paid by HPPCL.
- xxvii. One day rest to the labour after continuous working of 6 days should be given and shall be ensured by the contractor.
- xxviii. All statutory provisions of various Labour Laws/Acts, PF Rules and other Statutory Provision should be duly complied with.
