Incorporation of Provisio 22 under Rule 5 of HPPCL CDA Rules -

In order to meet the issue of unauthorized/ willful absences including on transfer; the proviso 22 is hereby incorporated in Rule 5 of HPPCL CDA Rules as hereunder:-

22. Willful / Unauthorized absences from duty not covered by grant of leave will be treated as dies non for all purposes viz., increment, leave and pension, if applicable. Individual cases of unauthorized absence from duty (including in transfer cases) which is not in pursuance of concerted action by a group of employees acting in combination, is to be treated as Dies non. Dies non does not constitute break in service, but only the days treated as dies non are not counted as duty for any purpose.
