In exercise of powers vested in it under Article 71 (xl) of Article of Association of HPSEBL, the Himachal Pradesh State Electricity Board Limited is pleased to make the following regulations namely:-

1. Short title and commencement:-

- (i) These regulations may be called the Himachal Pradesh State Electricity Board Limited (Category / post wise Revised Pay) Regulations, 2014.
- (ii) They shall come into force with effect from the date as mentioned in Column 8 of the "Schedule" appended to these regulations.

2. Application:-

DIN (8) PA

Save as otherwise expressly provided by or under these regulations; they shall apply to only to such categories of regular Himachal Pradesh State Electricity Board Limited employees as mentioned in the aforesaid Schedule;

Provided that the Himachail Pradesh State Electricity Board (Revised Pay) Regulations, 2009 issued vide office order No. 8 HPSER (SECTI.) / 2009 dated 30.12,2009 and subsequent amendment(s) thereto shall not apply to the category/ post of employees as mentioned in the "Schedule".

- <u>Definitions</u>:-In these regulations unless there is anything repugnant in the subject or context:
- (a) "HPSEB Ltd." means Himachal Pradesh State Electricity Board Limited.
- (b) "Existing HPSEB Ltd. employee" means a HPSEB Ltd. employee who is in the HPSEB Ltd. service on or before the date of commencement of these regulations.

pay in the pay band" means the pay being drawn in the running pay band by HPSEB Ltd. employees as per Column-5 of Schedule appended to Himachai Pradesh State Electricity Board (Revised Pay) Regulations, 2009.

Grade Pay" means fixed amount corresponding to the Revised pay scales as specified on column 6 of appended to Himachal Pradesh State Electricity Board (Revised Pay) Regulations, 2009.

"Pay Structure" in respect of any category/post mentioned in column-2 of the Schedule is the pay band and grade pay, specified in column No. 4 & 5 read with column 6 of the 'Schedule' of these regulations.

"Pay in the pay band" means the pay drawn on the date of application in the revised pay band as specified in the column 5 of the Schedule.

- (g) "Grade Pay" means the fixed amount as mentioned in the column No. 6 read with corresponding pay band in column 5 of the 'Schedule" against each category of the post.
- (h) "Schedule" means the Schedule appended to these regulations.
- 4. <u>Drawl of pay in the different Pay Structure:</u> Save as otherwise provided in these regulations, an HPSEB Ltd. employee shall draw pay in the respective pay structure applicable to the post to which he is an appointee as on the date of commencement of these regulations or thereafter.
- Fixation of Pay:- The pay of an HPSEB Ltd. employee unless in any case, the HPSEB Ltd. by special order otherwise directs, be fixed in the following manner, namely:-
 - (i) In case of existing HPSEB Ltd. employees, the existing pay being drawn in the relevant pay band will be protected and higher grade pay as applicable to the category/post as mentioned in the "Schedule" will be granted.

Provided that if there is change in the pay band of an employee and in case the existing pay of such employee comes to less than the minimum of the revised pay band, then the employee shall draw the minimum of the pay band and grade pay of the post as mentioned in the "Schedulu" replies the relevant category/post.

- (ii) In case of a regular HPSEB Ltd. employee appointed on or after the date of commencement of these regulations, the pay will be fixed at minimum of the pay band plus grade pay as mentioned in the "Schedule" against the respective category/post.
- (III) In the case of an existing HPSEB Ltd. employee who is governed under these regulations and who has been allowed special increments after putting in specific period of regular service under any regulations/executive instructions issued by HPSEB Ltd. shall not be entitled to any special increments in future. However, the pay of existing Board servant of specific categories who have earned such special increments shall not undergo any change and will be protected.

 Note:- HPSEB Ltd. employee who is on leave on the date of commencement of these regulations and is entitled to leave salary, shall become entitled to pay in
- Rate of Increment: The rate of increment will be (3%) three percent of the sum of the pay
 in the pay band and grade pay applicable which will be rounded off the next multiple of Rs.
 10. However, the amount of decimal fraction will be ignored.

the "Pay Structure" from the date of such commencement.

7. Date of next Increment: The next Increment of an HPSEB Ltd. employee, whose pay has been fixed in the respective "Pay Structure in accordance, with Rule 5, shall be granted on the date, he would have drawn his increment, had he continued in the existing pay structure.



Provided that the next increment of an HPSEB Ltd. employee whose pay is fixed at the minimum of the respective Pay Band, shall be granted after completion of qualifying service of 12 month in that pay Band.

- 8. Impact of grade pay enhanced earlier: Grade pay of Rs. 150 enhanced vide office order No.7/HPSEB (Sectt.) / 2011 dated 01.10.2011 in respect of various categories of employees whose Grade Pay is being revised as per this Regulation shall not be admissible w.e.f. 01.10.2012. As a result the enhanced Grade Pay of Rs. 150 will not be payable w.e.f. 01.10.2012. This amount shall be subsumed in the Grade Pay enhanced w.e.f. 01.10.2012 and the arrears would be calculated accordingly.
- Mode of payment of arrears: Notwithstanding anything contained in these regulations, the arrears on account of revision of pay w.e.f 01.10.2012 will be paid in such manner and such time as may be decided by the HPSE8 Limited. The revised pay in these regulations shall be drawn from Ist. day of OCK, 2014.
 - Note: It shall be the responsibility of the concerned DDO to ensure correct fixation of pay in the revised pay structure. However, in case any discrepancy in fixation of pay is noticed resulting in overpayment such amount shall be recovered from the concerned employee. An undertaking will be obtained from every employee before the disbursement of arrears to the effect that any excess payment made as a result of incorrect fixation of pay in the revised pay structure or for any other reasons will be refunded him / her to the HPSEB Ltd. against future payments or otherwise. A specimen of the form of the undertaking enclosed with office order No. 8 dated 30.12.2009 shall be used for this purpose.
- Overriding effect: The provisions of Fundamental Rules and various order issued there under, from time to time, and the Rimachal Pradesh State Electricity Board (Revised Pay) Regulations, 2009 as well as various orders issued hereunder, by the Himachal Pradesh State Electricity Board/Himachal Pradesh State Electricity Board Limited with regard to pay revision and fixation of pay shall not save as otherwise provided in these regulations apply to cases where pay is regulated under these regulations, to the extent they are inconsistent with these regulations.
- 11. Power to amend the Schedules-The Himachal Pradesh State Electricity Board Limited may by orders add to or delete from the Schedule any entry or otherwise amend the Schedule and thereupon the Schedule shall be deemed to have been amended accordingly.
- 12. Power to relax: Where the Himachal Pradesh State Electricity Board Limited is satisfied that the operation of these regulations causes undue hard ship to any individual HPSEB Ltd. employee, it may by an order in writing relax or dispense with any of the provisions of these regulations to such extent and subject to such conditions, as it may consider necessary.
- Interpretation: If any question arises relating to the interpretation of any of the provisions
 of these regulations the Himachal Pradesh State Electricity Board Limited shall decide the
 same.

Instructions regarding granting of benefits under Scheme of 9/16 years TRPS & 23 years Advance Promotional Increment after post based revision of pay structure/Grade Pay w.s.f. 1.16.2012 in respect of HPSEB Ltd. employees in term of HPSEB Ltd. Category wise/Post wise Revised Pay Regulations-2014.

On the subject cited above, I am directed to invite reference to office orders No.3/HPSEBL (SECTT.)/2012 dated 16.8.2012 endst. No. HPSEBL (SECTT)/SA/ Scale-1-1/2012-51023-242 dated 16.8.2012 & further corrigendum No. HPSEB (SECTTY SA/Scale-1-1/2012-53333-553 dated 23.8.2012 and amendment office order No.13/HPSEB (SECTT)/2012 dated 28.32.2013 which provide that an eligible HPSEB Ltd. employee who is not promoted to a higher level on account of non availability of a vacancy or non existence of a promotional avenue in the cadre, is eligible for the henefit of 9/16 years under TBPS & 23 years Advance Promotional Increment, as per instructions/conditions contained therein.

The HPSES Ltd. has allowed revised Grade Pay by way of application of Schedule appended under HPSEB Ltd. Category wise/Post wise Revised pay Regulations, 2014 with effect from 1.10.2012 onwards vide Office Order No. 4 /HPSEBL(SECTT)/2014- dated 01-14-2414 to various categories of employees. This re-revision of pay has increased pay of various categories of employees,

The matter has been considered by the HPSEB Ltd. and it has been decided that for the purpose of granting benefit under 9/16 years & 23 years Scheme, this re-revision of pay under the Rules 2014 ibid shall be treated as financial enhancement. Accordingly, in the case of those categories of employees to whom the HPSEB Ltd. Category wise/Post wise (Revised pay Regulations-2014), are applicable and whose pay band or grade pay has increased, the qualifying period of granting benefit 9/16 TBPS & 23 years Advance Promotional Increment shall commence from the date of application of the Regulation ibid. The Time Bound Promotional Scheme shall stand modified accordingly.

- The decision would also be applicable to persons to whom the aforesaid Rules are applicable and who have been granted TBPS Scale on or after 01,10,2012. In case of persons who have already been granted TBPS on or after 01.10.2012 and who are also eligible for re-revision of pay under the ibid Regulation of 2014, the financial enhancement/enhanced financial benefits given under the TBPS Scheme on or after 01.10.2012 would be subsumed in the financial benefits accruing due to re-revision of Grade Pay under the HPSEB Ltd. Category /Post wise Revised Pay Regulations-2014 and adjusted accordingly or in any other manner. In terms of the aforesaid decision regarding the qualifying period of grunting benefit under TBPS Scheme, it is clarified that these persons would be entitled to get the benefit of TBPS benefit from a future date, as may be applicable in their case.
