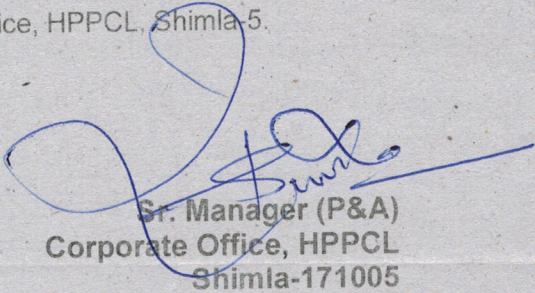

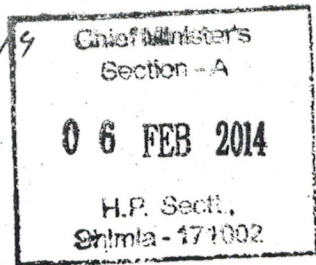

Subject: Providing of employment after completing all codal formalities.

Sir,

I am directed to say that applications are received in Chief Minister Office from the public representatives or directly from the public requesting therein for appointment in Government Sector or PSUs and these are examined by Chief Minister's office and are sent to the concerned Government Offices/PSUs for necessary action.

In this regard, it is categorically clarified that the import of such orders by Chief Minister Office is that these applications should be examined on merit and further action taken as per Government Rules, regarding providing of employment. It necessarily means that such applications should be processed after observing all codal formalities, wherever necessary. In no case the orders conveyed by Chief Minister's Office ought to be treated by the Department as mandatory for providing employment to such applicants and in case any Government Department/PSU has interpreted the orders of C.M. office in a way that employment has been provided without observing codal formalities, such orders may be reversed and action may be taken in such cases as per Government Rules.

You are, therefore, requested that the above instructions may kindly be adhered to strictly in letter and spirit and brought to the notice of all concerned under your control for its strict compliance.
