The nomenclature & level mentioned in the Table above for Supervisory and workmen category is subject to revision/change as per approved Policy for Promotion of Supervisors and proposed Policy on Promotion of Workmen under submission to GoHP for approval.

- (i) The Grade pay enhanced earlier by Rs. 150/- as per O/O No. 7 Dt. 1/10/11 of HPSEBL and further approved by BOD vide Item No.32.09 in case of employee recruited and regularized on or before 01/10/2011 shall not be admissible w.e.f. 01.10.2012. This amount shall be subsumed in the Grade Pay enhanced w.e.f. 01.10.2012 and the arrears would be calculated accordingly.
- (ii) Grade pay enhanced earlier by Rs. 150/- as per O/O No. 7 Dt. 1/10/11 of HPSEBL and further approved by BOD of HPPCL vide Item No.32.09 in case of existing contract employees in whose cases the enhancement of Rs. 150/- has already been paid since 01.10.2012 shall cease from immediate effect and no recovery shall be made to this effect.
- (iii) Date of applicability of above enhancement in HPPCL shall be same as in HPSEBL i.e. w.e.f. 01.10.2012 or after two years of regular service, whichever is later.
- (iv) The arrears on account of revision of pay w.e.f. 01.10.2012 will be paid in such manner and at such time as may be decided by the HPSEBL or HPPCL. Whereas, the revised pay shall be drawn from 1st day of October, 2014.
