#### Office order

The Board of Directors in its 11<sup>th</sup> meeting held on 2<sup>nd</sup> July, 2008 approved the following policy for use of company vehicles: -

- Company owned vehicles will be provided as attached vehicles to only GM level and above officers and HOP's (any rank).
- Hired attached vehicles will be provided to DGM and above. Sr. Managers
  in field who are required to travel frequently may also be provided
  attached hired vehicles.
- 3. A pool of vehicles will be maintained for other duties in corporate office as well as project offices under the control of designated vehicle incharge. Pool vehicles will be hired vehicles unless some company owned vehicle is available.
- 4. Log books will be signed by the officers using vehicles. Idle journeys or journeys where officer is not sitting in the vehicles will also be signed by the officer with whom the vehicle is attached for the attached vehicles and by the designated vehicle In-charge for pool vehicles. Journeys for use of company guests or other important dignitaries may be signed by the designated vehicle in charge.
  - 5. All executives will be entitled to use pool vehicles for official journeys.
    Non-executives may be allowed to use official vehicles if allowed by the Directors or by HOPs if the work is such that they have to travel by vehicle.
