Increase in promotional quota for Supervisory category employees- amendment thereof in Proviso 5.2 of "Policy Statement on Manpower Recruitment" & Proviso 3.2.2 of "Policy regarding promotion of supervisor"

In pursuance to the recommendations of the Service Committee held on 06/12/2021 on Agenda item No.5 and subsequent ratification by the Board of Director's, HPPCL in its 78<sup>th</sup> Meeting held on 06/01/2022 vide agenda Item No. 78.29, Management of HPPCL is pleased to Increase promotional quota from existing 25% to 33% for promotion from Supervisory level to the induction posts of Executive level and make subsequent amendment thereof in Clause 5.2 of "Policy Statement on Manpower Recruitment" & Clause 3.2.2 of "Policy regarding promotion of supervisor" given as under, with immediate effect.

Further, one time relaxation is allowed to all the existing incumbents in categories of Junior Officer(R&R) & Junior Office(IT), who have completed or shall complete 13 years of service in Supervisory category by filling up of the 100% of remaining vacant posts at induction level in Executive level of AO(R&R) & AE(IT) as a one time measure, subject to availability of vacancy and fulfilling the eligibility conditions, subsequent, to which the promotion quota will remain 33% for these categories.
