The practice of issuance of separate sanction orders at the end of P&A Department after "Change of Posting" & "Promotion/Placement/Grant of Equivalence" is currently in place, to allow the employees to receive Mobile Reimbursement; which is a level based Perk as already notified vide Circular No. 23 dated 18.08.2009 and Circular No. 34 dated 15.01.2021. However, it has been observed that, the "Promotion/Placement/Grant of Equivalence" related orders are 'self speaking' in terms of consequential changes in levels, therefore, the practice of issuance of separate orders has been re-examined. Accordingly, to discourage creation of multiple documents, the practice of issuing separate sanction orders is hereby decided to be discontinued with immediate effect.

However, It has been further decided that a "Declaration Form" (*Format Enclosed*) for Mobile/Telephone reimbursement shall be filled by the all the employee at the time of joining as well as at the time of update in Telephone/Mobile Numbers.
